Agreement with Grand Lake Sailing Club

In consideration of being granted membership I/we agree to the following

1. I/We assume the risk of using all club facilities and agree to make no claims against the club for injuries to myself or my property.
2. I/We agree to hold the club harmless from any damage that may be claimed because of act(s) performed by me or damages caused by my property whether occurring while attending or being operated by me or someone at my direction with my consent.
3. I/We agree to comply with the boating laws of Oklahoma, Grand River Dam Association and the Grand Lake Sailing Club ByLaws and Standing Rules.
4. I/We agree to pay all dues and slip fees when due.
5. If I/we do not pay dues and fees when due, I/we authorize the Baard of Governors (BOG) to remove my boat from its slip to the appropriate storage area. Such removal shall be without liability on the part of GLSC.
6. I/We agree to maintain liability insurance in the minimum amount of \$100,000 and provide evidence of insurance with this application and with yearly dues payment.
7. I/We agree to be responsible for any or all damages to club property caused by my/our boat being improperly tied or secured.
8. I/We hereby grant the BOG the right to move or relocate my/our boat in the event of an emergency, or for maintenance or repair to club docks, grounds, or other facilities.
9. GLSC shall have no duty preventing the repossession of a member's boat, nor to determine the validity of a security interest in the member's boat or equipment. If GLSC becomes aware of the repossession of a boat or other item located on club property, their sole duty shall be to determine the identity of those effecting the repossession.
10. This agreement shall continue in effect during the time of my/our membership in the GLSC. The provisions of this application shall be binding upon the heirs, executors and administrators of the applicant(s) and is not assignable.
11. This agreement shall be interpreted under the laws of the State of Oklahoma.
